**I TECHNICAL DETAILS**

**I.1 Category**

Mandatory.

**I.2 Airplanes Affected**

Type: DA 40 NG

S/N: All equipped with Quick Fix Baggage Net Assemblies P/N D44-2550-90-00 with dates of manufacture (DMF) of December 2015, November 2016, or March 2017.

Prior compliance with Factory Campaign FC 40N-100 or MSB 40NG-065 Rev. 0 precludes compliance with this service bulletin.

**I.3 Date of Effectivity**

06 July 2021

**I.4 Time of Compliance**

At next maintenance action, but no later than 50 hours air time from the date of effectivity.

**I.5 Subject**

Replacement of baggage nets with defective buckles.

ATA code: 25-50

**I.6 Reason**

It has come to Diamond's attention that baggage nets with defective buckles have been installed on several aircraft due to a quality escape. These defective buckles may not maintain sufficient holding force and could pose a hazard to the passengers and crew. Effective immediately, these cargo nets are not to be used. Diamond will provide replacement nets to all those affected.

**I.7 Concurrent Documents**

None.

**I.8 Approval**

The technical content of this document is approved as part of the type design.

**I.9 Accomplishment/Instructions**

1. Refer to Section I.2. Identify if the baggage net in the aircraft is an affected net. Use the part number and date of manufacture to identify the net.
2. If an affected net is installed, clearly mark the currently installed net as defective, and remove it from the aircraft.

**CAUTION:** DO NOT LOSE TRACK OF WHICH NET IS DEFECTIVE, AND WHICH NET IS THE NEW NET. IF DOUBT ARISES OVER WHICH NET IS DEFECTIVE, BOTH MUST BE DESTROYED.

3. Destroy the removed baggage net, or return it to Diamond Aircraft Industries.
4. Install the new baggage net provided by Diamond Aircraft Industries.

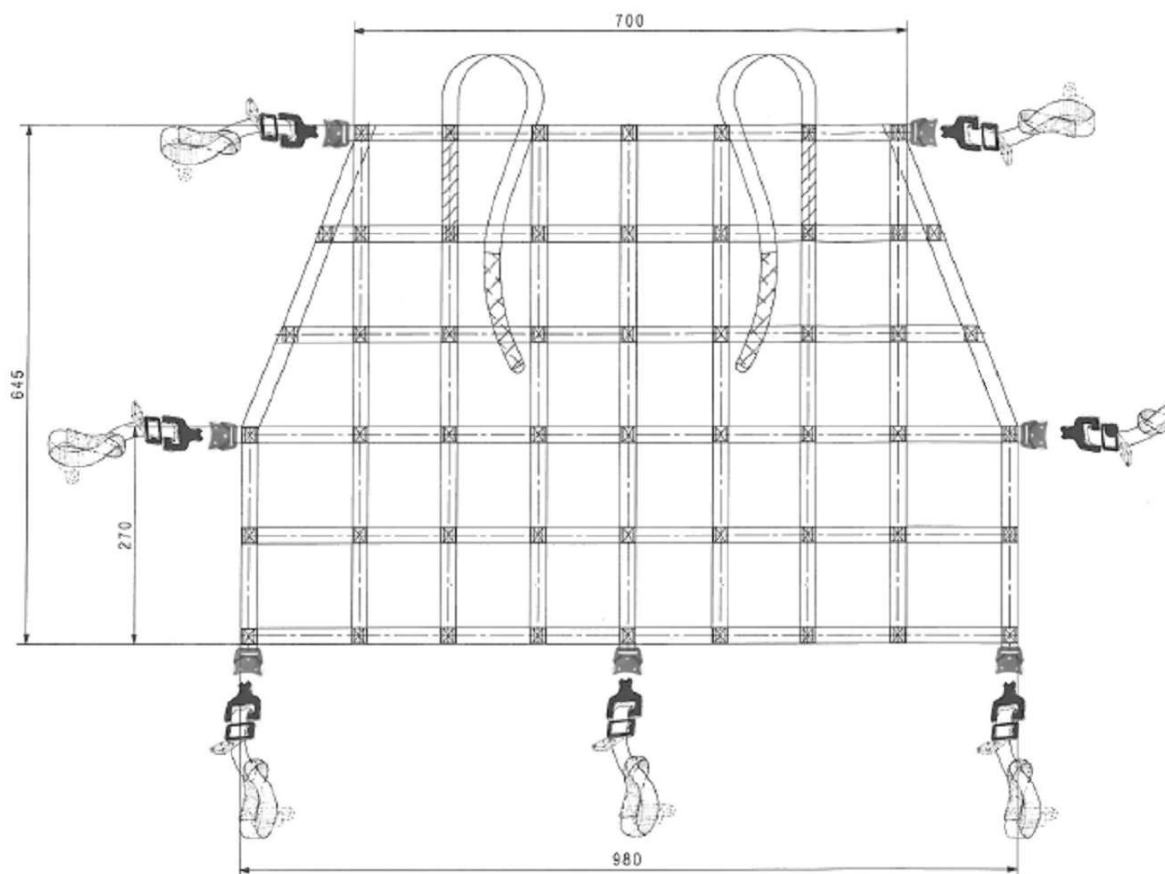


Figure 1 - DA 40 NG baggage net installation.
