The EASA has issued Airworthiness Directive No. 2012-0180 mandating installation of a temporary placard in the cockpit within 25 flight hours or 30 days whichever occurs first, in reference to Diamond Aircraft Industries Mandatory Service Bulletin MSB 40NG-016. Furthermore this Airworthiness Directive requires modification of the airspeed indicator markings.

	(3) Within 9 months after the effective date of this AD, for aeroplanes with conventional cockpit instruments, modify the airspeed indicator markings in accordance with the instructions of DAI AFM-TR-MÄM-40-618 (to be issued).
