3.11 SMOKE AND FIRE

The note is amended to read:

NOTE

The fire extinguisher is located on the cabin floor behind the co-pilot's seat.

If AIR TOTAL HAL 1 is installed: To release the fire extinguisher out of the fire extinguisher mount, pull the fire extinguisher at the nozzle near the Y-spring.

If Amerex A620T (OÄM 42-127) or Amerex 337TS (MÄM 42-1265) is installed: To release the fire extinguisher out of the fire extinguisher mount, open the holding strap and pull the fire extinguisher out.
