1. **TECHNICAL DETAILS**

1.1 Aircraft Affected

All DA 62 aircraft

1.2 Subject

Air Intake System Hose ATA-Code: 71-60

1.3 Reason

It has come to DAI's attention during maintenance actions DA 62's may have had generic SCEET hoses installed. As this could compromise the engine air intake system and possibly result in engine power loss, DAI recommends replacing any hose found in the air intake system if it cannot be determined to be a DAI part. This Service Information Letter provides guidance in identifying what the correct installation is and provides instructions for rectification if necessary.

Information

DAI recommends using the information listed below to identify the SCEET hose and replace if needed.




Figure 1: Left - SCEET Hose, Right - Current DAI Part

1.4.1 As shown in Figure 1 below, the SCEET hose can be identified by the "Aeroduct Product" stamping (or other reference), single string reinforcement and non-reinforced ends. The DAI part can be identified by the double stitching and in later serial number, the reinforced ends.

1.4.2 Customers are advised to confirm the correct part is installed on their DA 62 aircraft. The hose is installed in the air intake system between the alternate air valve and the turbocharger. Location of the hose is shown in Figure 2 below.

- 1.4.3 Upon inspection, if you cannot positively identify the hose as a correct DAI part, remove and discard the hose.
- 1.4.4 Install the DAI hose (P/N DS-HA2-75-0380-30-45) and ensure proper fitting of the hose. For the hose clamp installation, refer to the DA 62 AMM Chapter 20-70-00.
