Reason:	In limited cases increased wear of camshaft/hydraulic valve tappet can occur. This may lead to improper engine operation, power loss or in-flight engine failure. BRP-Rotax Gmbh & Co. KG has issued Alert Service Bulletin ASB- 912-051 and ASB-914-034 respectively which describes a special inspection for the affected engines to address this problem.
	This Emergency Airworthiness Directive requires the inspection, as described in the referenced ASB's, to be carried out as indicated.
Effective Date:	17 October 2006
Compliance:	<ol> <li>Before the next engine start up from the effective date of this directive, inspect the magnetic plug in accordance with the instructions of BRP-Rotax ASB-912-051 or ASB-914-034, as applicable;</li> <li>Within 5 hours of operation after the effective date of this directive, but not later than 01 March 2007 and thereafter at every specified oil change,</li> </ol>
	<ul> <li>(3) If, during any of the inspections as required by paragraph (1) of this directive.</li> <li>(3) If, during any of the inspections as required by this directive, a greater quantity of metal parts than 3 mm is detected, the engine must not be taken into operation until the cause has been identified and eliminated;</li> <li>(4) After the effective date of this directive, no person may install one of the affected engines on any aircraft unless the magnetic plug has been inspected in accordance with the requirements of this directive.</li> </ul>
